RESOLUTION NO. 2023-006

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF AMES, TEXAS, APPROVING APPOINTMENT OF EMMETT ALBRO AS MUNICIPAL JUDGE OF THE MUNICIPAL COURT FOR THE CITY OF AMES; NAMING THE APPOINTED JUDGE TO A TERM OF SIX MONTHS; AND APPROVING A PROFESSIONAL SERVICES AGREEMENT ATTACHED AS EXHIBIT A

WHEREAS, Ordinance No. 2023-001 provides that the mayor shall appoint the municipal judge of the city, with approval by the city council as required under the laws of the State of Texas; and

WHEREAS, Ordinance No. 2023-001, provides that the municipal judge shall be compensated for his services at a rate set by the city council.

WHEREAS, the City is in need of a qualified municipal judge to preside over municipal court proceedings and to administer justice in accordance with the laws of the State of Texas and the ordinances of the City; and

WHEREAS, Emmett Albro possesses the qualifications to serve as the Municipal Judge for the City;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY AMES, TEXAS:

SECTION 1. Appointment of Municipal Judge

The City Council hereby appoints Emmett Albro as the Municipal Judge of the City of Ames, Texas, effective October 1, 2023, for a term of six (6) months.

SECTION 2. Approval of Professional Services Agreement

The City Council hereby approves the Professional Services Agreement ("Agreement") attached hereto as Exhibit A, which sets forth the terms and conditions of Emmett Albro's appointment as Municipal Judge. The Mayor is hereby authorized and directed to execute the Agreement on behalf of the City.

SECTION 3. Term of Appointment

The term of Emmett Albro's appointment as Municipal Judge shall commence on October 1, 2023, and shall continue for a period of six (6) months, unless earlier terminated in accordance with the Agreement or applicable law.

SECTION 4. Compensation

The compensation for Emmett Albro's services as Municipal Judge shall be as set forth in the Agreement.

SECTION 5. Severability

If any provision of this Resolution or its application to any person or circumstance is held invalid, the remainder of the Resolution or the application of the provision to other persons or circumstances shall not be affected.

SECTION 6. Effective Date

This Resolution shall take effect immediately upon its passage and adoption by the City Council.
