# 1. CITY COUNCIL TO CONDUCT A PUBLIC HEARING ON THE PROPOSED TAX RATE FOR FISCAL YEAR 2023-2024.

The Public Hearing began at approximately 6:09PM. Mayor Doman extended the opportunity for anyone to speak on the item at this time.

- ➤ Councilman Michael Trahan posed the question about The City of Ames Fiscal Year. (January 1<sup>st</sup> through December 31<sup>st</sup>)
- ➤ Mayor Domain Asked if 2023 should be removed from Ordinance NO. 2023-002

Marivious Allen – Explained that due to language used in the past by the Comptroller it is recommended that Ordinance NO. 2023-002 should remain as written.

The Public Hearing ended at approximately 6:10 PM.

2. CONSIDER AND IF APPROPRIATE TAKE ACTION TO ADOPT ORDINANCE NO. 2023-002 OF THE CITY COUNCIL OF THE CITY OF AMES, TEXAS, ADOPTING AN AD VALOREM TAX RATE FOR FISCAL YEAR 2023-2024 AT A RATE OF \$0.5000 PER ONE HUNDRED DOLLARS (\$100.00) OF ASSESSED VALUATION OF ALL TAXABLE PROPERTY; PROVIDING AN EFFECTIVE DATE.

Marivious Allen provided an explanation of the actions that are required to adopt the 2023-2024 Ad Valorem tax rate. He also explained that the actual tax rate will be decreased from last year; however, the value of property will increase which will generate an increase in revenue for the city. The proposed tax rate is \$0.50 cent per \$100 or 21.37%.

The property tax rate be increased by the adoption of a tax rate of \$0.5000, which is effectively a 21.37 percent increase in the tax rate," as reflected in Ordinance 2023-02.
